2. SUMMARY: Based on other published studies in pedagogical journals we didn't think we needed a control group (and given the importance of goal setting theory to our field we couldn't create one in our own classes by not teaching the subject in a section). However, after some discussion with other faculty, we decided we should have a control group for the basic pre- post knowledge and behavior surveys.				
We plan to use a required business course at each institution (Stonehill and Roanoke) with approximately the same level students (sophomore - junior). We will bring the survey to the classroom and the instructor of that class will step outside. We will explain the informed consent process and assure them that their professor will not know if they agreed to participate or not. The survey should take 5 to 10 minutes to complete. We will do this near the beginning and at the end of the semester. We will use the same protocol around keeping their data confidential as we use for the subjects.
