- #9 enter tax year 12/31/20
- Mail the form to the respective address listed on page 2 of the 4506-T under “Chart for all other transcripts”:
- The IRS will mail the Verification of Nonfiler letter to your home address

Upon receipt of the letter:

- Keep a copy of the letter for your reference
- **Write student name and Stonehill ID number** on the top right hand corner of the page
