Stonehill College Emergency Preparedness Review

As a result of the tragic events of April 16, 2007 at Virginia Tech, all colleges and universities began the process of a comprehensive review of their institution's emergency response plans.

Stonehill College began its review process this summer and has completed a draft of a detailed Emergency Management Plan that addresses many of the areas of concern in the Virginia Tech Report. This draft is currently under review and will be presented to the President for final approval. Once approved, the plan will be tested through a number of table top exercises conducted by the Emergency Response Team. The Crisis Management Committee will assess the effectiveness of the plan.

The review process and final report on the Virginia Tech incident, commissioned by the Governor of Virginia, compiled over 70 recommendations directed to colleges, universities, mental health providers, law enforcement officials, emergency service providers, law makers, and other public officials in Virginia and elsewhere.

Below is a review of 37 of the recommendations that have a direct impact on colleges and universities and should be addressed in their policies and procedures.

This additional training would include how to effectively respond to active shooters and other emergencies.
Dispatchers should be cautious when giving advice or instructions by phone to people in a shooting or facing other threats without knowing the situation.	Stonehill College has converted the former Switchboard function into a dispatcher function (communication officers) and requires formal training for handling emergency situations. Communication officers will also be provided a fact sheet to relay accurate information of emergency incidents.
Police should escort survivors out of buildings, where circumstance and manpower permit.	Campus Police training and protocols will include the handling of survivor evacuation methods.
Schools should check the hardware on exterior doors to ensure that they are not subject to being chained shut.	Stonehill College is currently assessing the hardware on exterior doors.
Take bomb threats seriously. Students and staff should report them immediately, even if most do turn out to be false alarms	Stonehill College bomb threat procedures requires all bomb threats to be treated as a serious incident.
